Treasurer's Report

<u>Membership</u>

Allan advised that as of today we have 89 active members and 8 new membership applications. Thirty members were moved to the inactive list as they have not paid their 2022 dues. Allan mailed them two dues notices and sent each one an e-mail. He noted that several of these memberships were those who had received free memberships from Mark's Marine for their purchase of a new Lund boat and we never saw them at a club meeting or function.

Allan advised that we have a new member who is a disabled veteran and who has inquired about obtaining dues-free status. We have no provision in our bylaws for that and we have a number of disabled veterans who would also have to be granted that same benefit if we approved this one. Allan moved and Travis seconded to deny this request. The motion carried unanimously.

ID Cards

Insurance

Allan advised that our club's insurance policy with Oregon Mutual expires on May 8th. Our premium this past year was \$600. Each time we scheduled or changed the scheduling of any club event Allan had to notify the insurance company, which is a hassle. Allan shopped for a better policy and found one with Liberty Mutual for \$511 annually that covers all of our club activities without the necessity of notifying them of event scheduling or changes. Allan moved and Mark seconded to make this change effective on May 9th. The motion carried unanimously.
